Symbols

All fiducial, bad and screen marks must be located asymmetrically. This to avoid faulty PCBs being fitted. Fiducials, bad and screen marks must be present on the primary side. When the design requires assambly on the secondary side, fiducials, bad and screen marks also needs to be present at the secondary side. These must be located identically on the secondary side compared to the primary side, as seen from the primary side.

- O PCBs must be labelled with year and week code and the manufacturer's logo.
- Selektro A/S do not accept faulty PCBs in a panel.
- Local bad marks shall be located symmetrically in the panel, one local bad mark per stepped PCB.
- Milling burrs on the panel must be sanded smooth.
- O PCBs with blue mask added must be packed with paper laid between the PCB's.

Gerber data must be supplied in extended gerber 274X format.
